INSTRUCTIONS

This form is used to complete the resignation and removal of attorney of an Alberta corporation extra-provincially registered in British Columbia in compliance with the provisions of the Trade, Investment and Labour Mobility Agreement (TILMA).

Submitting Party Information

• Enter the name, complete mailing address and telephone number of the submitting party. The submitting party may be a firm or an individual.

Alberta Corporation Registration Information

- Enter the name of the corporation.
- Enter the Alberta corporate access number.
- Enter the date of registration in Alberta.

Type of Amendment: Resigning and Removal

British Columbia Attorney for Service

- Enter the full name of attorney resigning. The attorney may be an individual resident in BC **or** a company incorporated in BC. One or more attorneys may resign. Enter each attorney separately.
- Enter the full attorney mailing address. The mailing address must be in BC and can be a post office box.
- Enter the head office notification of resignation date (must be today's date or a past date.)
- Enter the resignation effective date (must be at least two months after the date on which the head office was notified of the resignation).

The form must include:

- The name of the authorized representative
- Title (relationship to corporation)
- Signature
- Date signed
